<u>The Council</u> adopted its position on draft amending budget No 2 to the general budget for 2014.

Policy debate

<u>The Presidency</u> launched a policy debate on the legislation proposal on organic farming (doc. 7956/14) currently under discussion by the Council Working Party on Foodstuff Quality.

Almost all delegations took the floor. <u>Most delegations</u> welcomed the intention of the Commission to improve the current legislation to boost the organic sector and to maintain the confidence of consumers. However, many Ministers expressed their concerns to such a drastic change to the current legislation considering that it may constitute a risk for the growth of the organic sector. <u>The Austrian delegation</u> strongly criticised the proposal as unnecessary and asked the Commission to withdraw it.

The debate concentrated on three questions tabled by the Presidency (doc. 11479/14) related to the removal of exceptions to organic production rules as well as the reform of controls and delegated acts.

The following concerns were expressed:

- On exceptions to the rules of production, they should not be withdrawn as proposed, otherwise there is a risk of operators being forced to leave the organic sector. Therefore flexibility is needed. Most Ministers insisted, for instance, on keeping the possibility to set 'mixed farms', and to use non-organic seeds.
- On controls, many delegations considered that the provisions should be kept in the "bio" regulation and not in the horizontal "official controls" regulation. Ministers expressed divergent views on the type of controls (annual controls versus risk based controls).
- On delegated acts, all Ministers considered that the broad use of delegated acts in the
 text is unjustified. Essential elements should be enshrined in the body of the text. Some
 Ministers considered that the amendments of rules of production should be established
 via implementing acts.

<u>The Council</u> held an exchange of views on a Commission Communication concerning a consultation on fishing opportunities for 2015.

<u>The Commission</u> noted the improved state of several stocks but expressed concern at the poor state of stocks in the Mediterranean.

<u>Most of the Member States</u> highlighted an overall improvement of the state of the fish stocks, as presented in the Communication. They noted the better scientific knowledge of the stocks in the Mediterranean, which brings to light some concerns about overfishing.

Several delegations underlined the need to set the total allowable catches (TACs) discussed later this year by taking into account the maximum sustainable yield (MSY) by 2015 where possible and by 2020 at the latest, and indicated the need to look at other factors when assessing potential exceptions. Some others stressed the need to respect the commitment made to the MSY by 2015 as a main objective. Many Member States pointed out the need to clarify the consequences for the TAC proposals of implementing the obligation to land all catches which was introduced by the reformed Common Fisheries Policy (CFP).

Management plans were supported as an effective management tool and there were calls for additional plans, with a mixed fisheries approach.

Many delegations highlighted the need to secure a level playing field with third countries when managing joint stocks in an international context, in particular in the case of the Mediterranean and Black Sea. Some delegations considered also that some stocks such as hake and Bluefin tuna are in a better state than presented in the Communication, due to big efforts made in efficiently managing these stocks.
