"Several Member States and MEPs have highlighted that certain islands and outermost regions have specific characteristics, both geographically and in terms of the economic dependence caused by their distance, remoteness, and small markets, which make them particularly vulnerable to the effects of natural disasters. In these regions, any natural disaster has an aggravated impact and there is a greater need for assistance.

Malta and Cyprus support that special treatment for certain type of regions is well safeguarded and recall that Article 174 of the TFEU, the related Declaration (33) and paragraphs 44 and 51 of the European Council Conclusions of 7-8 February 2013 recognise the specific character of Island Member States.

Malta and Cyprus consider that the regional threshold exists to facilitate the ability of smaller regions to access the Fund and our position remains that the situation of Island Member States such as Malta and Cyprus, and the vulnerability of such territories to natural disasters should be reflected in the legislative proposal."

This directive provides a response to the call of the European Council within the Stockholm Programme to set up a comprehensive system for obtaining evidence within the EU, based on the principle of mutual recognition, and to replace all the existing legal instruments in this area, including Framework Decision 2008/978/JHA of 18 December 2008 on the European evidence warrant. However, due to various interpretations of the legal basis of the Directive, Article 34(2) only provides that this Framework Decision is replaced for the Member States bound by the Directive. The Austrian, Belgian, Bulgarian, Dutch, Estonian, French, German, Italian, Luxemburg, Spanish, Swedish and Slovenian delegations urge the Commission and the Presidency to consider possibilities to ensure legal clarity on the repealing of the Framework Decision 2008/978/JHA for all Member States."

"The UK considers that the signature and conclusion of the Protocol to the Partnership and Cooperation Agreement between the European Communities and their Member States, of the one part, and the Republic of Azerbaijan, of the other part, on a Framework Agreement between the European Union and the Republic of Azerbaijan on the general principles for the participation of the Republic of Azerbaijan in Union programmes is an exercise of the EU's external competence in relation to the various sectoral policies pursued by the underlying programmes. Therefore the substantive legal bases for the underlying programmes should have been cited as the legal bases for these proposed Decisions on signature and conclusion. Further, where the programmes have justice and home affairs content, the proposed Council Decisions should cite the relevant legal bases from Title V of Part Three TFEU. Accordingly, we do not consider that Article 212 TFEU is appropriate as the sole substantive legal base for these proposed Decisions.

As with the similar Council Decisions on signature and conclusion of an equivalent Protocol related to Georgia, the UK remains concerned that the Council has not been provided with the particular list of Union programmes which Azerbaijan will be eligible to participate in prior to the Council being asked to adopt these Decisions."

<u>The Committee</u> examined the text and gave the Presidency a clear mandate to conduct negotiations with the European Parliament at the informal trilogue on 19 March 2014.

The Presidency recalled that this point was put on the Council agenda at the request of the Danish delegation, the main stakeholder in the sandeel fishery, as the fishing season starts on April 1st and the necessary legislation enabling this fishery needs to be put in place before that date. The Commission confirmed that the proposal based on the newly available scientific advice will be ready for discussion in the Working Party on Internal and External Fisheries on 18 March 2014. The Presidency indicated that all efforts will be made in order to finalise this work within this timetable. The Danish and Spanish delegations indicated their support for the approach chosen for this file. The Presidency concluded that the Committee prepared this item and decided to keep it on the agenda of the Council.

- 2. Coastal States consultations on mackerel and EU/Norway bilateral consultations (*Non-legislative activity*)
  - State of play and exchange of views

The Commission updated the Committee on the latest developments regarding the mackerel Coastal States and the EU/Norway bilateral discussions. The EU played a broker role in this process and tried to bring all the parties together on mackerel. The EU/Norway bilateral arrangement is agreed at the technical level, but mackerel is still staying in the way of an agreement. The Commission undertook to promptly brief the Council on the results of these discussions. While a number of delegations agreed with the need to have agreements on these two issues, the Belgian delegation supported by the Spanish, Portuguese, French and Maltese delegations expressed strong concerns with the provisions related to fully-documented fisheries inserted in the draft EU/Norway bilateral arrangement.

7600/14 15 DPG **E.N**  <u>The German delegation</u> expressed regrets that Iceland decided to act unilaterally on mackerel. <u>The Commission</u> explained that the Council will have the opportunity to endorse the final result in the context of an amendment to the annual fishing opportunities regulation. <u>The Presidency</u> concluded that <u>the Committee</u> had prepared this item and decided to keep it on the agenda of the Council.

#### 61. Preparation for the Council meeting (Foreign Affairs) on 17 March 2014

#### a) Eastern Partnership

Ukraine (restricted session)

<u>The Committee</u> on 12 March 2014 discussed preparations for the Ministerial debate regarding Ukraine, to be held the day after the planned referendum in Crimea. Delegations underlined the need for a thorough preparation of the debate, allowing the Council to take the necessary decisions as envisaged in the statement of the Heads of State or Government of 6 March 2014.

Following the discussion in <u>the Committee</u> on 12 March 2014, <u>the Committee</u> considered a revised draft Council decision on the signing and provisional application of the political provisions of the Agreement and the related draft Final Act, and reached agreement on both. It decided to submit the draft Council decision and Final Act to the Council (Foreign Affairs) on 17 March 2014 for adoption.

The Committee held a restricted session on 16 March 2014 in preparation of the 17 March 2014 Council meeting, and reached agreement on draft Council conclusions on Ukraine as set out in 7782/1/2014 REV 1 as well as on restrictive measures in respect of actions undermining or threatening the territorial integrity, sovereignty and independence of Ukraine.

#### b) Bosnia and Herzegovina

A number of delegations called for sufficient time to be allotted to the issue of Bosnia and Herzegovina in the Council, so as to ensure a substantial discussion. These delegations also called for Council conclusions at the April Foreign Affairs Council.

#### c) Middle East Peace Process

The item was not in particular discussed by <u>the Committee</u> and was only addressed in the context of the general handling of the Foreign Affairs Council.

- The EEAS (SG Vimont) presented the <u>draft agenda</u> of the meeting and an overall view of the Joint Statement which is still under negotiation with the American side (cf. 7515/14). The main issues will be the economic situation in the EU and the US, TTIP, climate change and energy issues, digital society, privacy and data protection, and foreign and security policy cooperation including Ukraine, MEPP, Iran and Africa. No major changes are expected in the Joint Statement and a new version will be circulated to the Member States following the first exchange with the US partners.
- The Commission confirmed TTIP as the main topic of the Summit, with a view to lending additional impetus and political commitment to conclude the TTIP negotiations. Ukraine would certainly dominate the discussions. The Summit would also help to rebuild trust in data protection and to verify the level of commitment in agreements such as the Umbrella Agreement and the Safe Harbour. The Commission also reiterated its commitment on visa reciprocity.
- Some delegations intervened on specific points (TTIP/transparency, data protection,
   EU-US Cyber dialogue, energy/LNG export and EU-NATO relations).
- The Committee took stock of COTRA, PSC and TPC work so far on the basis of their chair's reports and requested COTRA to coordinate and to follow the preparations of the Summit
