Subject : The European Union Action Plan for Combating Radicalisation and Recruitment to Terrorism

1. Delegations will find attached the revised EU Action Plan for Combating Radicalisation and Recruitment to Terrorism. This draft reflects the discussion at the 4 November joint TWG/COTER and the written comments the Presidency received following that discussion. This meeting followed discussion of the issues at a special meeting of the Article 36 Committee in July, the special session of COREPER in September, as well as in TWG and COTER in October.
2. As has been previously discussed, the Action Plan will remain classified EU Restricted once agreed.
3. The document is forwarded to the Article 36 Committee, and the Political Security Committee (on the external relations dimension) for discussion and agreement. It will then be forwarded to COREPER on 23 November and the December JHA and GAERC Councils.
