⁷ CY has indicated that it complies with the provisions on freezing of property whilst legislative work is ongoing so as to comply with the provisions on freezing of evidence.

⁸ UK has indicated that it has implemented the FD on freezing orders insofar as terrorist assets are concerned. UK is making progress towards full implementation.

⁹ This Decision repeals Decision 2003/48/JHA which was among the listed instruments in previous versions of this document. All MS have implemented the decision as far as the obligations to designate "a specialised service within its police services or other law enforcement authorities" (art. 2.1.) and a "correspondant" for Eurojust for terrorism matters (art. 2.2) are concerned (these obligations were already contained in Decision 2003/48/JHA and have been copied in the decision of 2005). Therefore, the table refers only to the obligation to ensure systematic transmission of information to Eurojust: the criteria used is whether or not the MS have adopted measures which are binding for the competent authorities concerned. The basis for this evaluation is the replies of MS to questionnaire 11143/07 EUROJUST 37 EJN 19 COPEN 103.

¹⁰ Articles 3(3) and (4) of the Protocol concerning the conditions and arrangements for admission of the republic of Bulgaria and Romania to the European Union (See Official Journal L 157, 21/6/2005, p.29) read as follows:

[&]quot;3. Bulgaria and Romania accede to the conventions and protocols listed in Annex I. Those conventions and protocols shall enter into force in relation to Bulgaria and Romania on the date determined by the Council in the decision referred to in paragraph 4."

[&]quot;4. The Council, acting unanimously on a recommendation by the Commission and after consulting the European Parliament, shall adopt European decisions making all adjustments required by reason of accession to the conventions and protocols referred to in paragraph 3 and publish the adapted text in the Official Journal of the European Union."

The Annex referred to in paragraph 3 lists the following Conventions as well as the Protocols amending or supplementing these Conventions:
