This table deals only with implementation of Decision 2005/671/JHA as far as transmission of information to Eurojust is concerned. It is based on the report issued by Eurojust and which will also be issued as Council document (doc. 9553/08 RESTREINT UE). The criteria used here to determine whether or not Member States have implemented the Decision is their reply to question "Have your national authorities developed procedures to ensure selection and transmission of information to Eurojust?". Without any procedure to ensure selection and transmission of information, it is difficult to see how Member States can be considered as having implemented the Decision.
