#### 1. WTO issues

#### 1.1 **DDA**

The Commission debriefed the Committee on the latest developments in Geneva **DELETED**

### 1.2 WTO General Council on 22 and 23 February

The main items on the agenda were: the report of Pascal Lamy on the state of the negotiations, the work programme on small economies, the role of the WTO on the financial crisis (requested by Argentina, Ecuador and India), the accession of developing countries, the information on the EU schedule CXL and the appointment of chair persons to the WTO bodies.

The Presidency concluded that the Committee had taken note of the information provided by the Commission on the preparations of the WTO General Council meeting on 22-23 February and indicated that the Committee had invited the Commission to circulate the EU statement on EU schedule CXL before it will be distributed to the other WTO members.

## 2. Bilateral/Regional Issues

2.1. EU-Central America Association Agreement: debrief on the informal meeting of Chief Negotiators for trade (1-3 February 2010), and preparations for the 8th round of negotiations

# 2.3 Eastern Partnership, Preparations of the 1st meeting of the Panel on "Trade and Trade Related Regulatory Approximation linked to DCFTAs" (Brussels, 29-31 March 2010)

The Commission informed the Committee on the meeting of the Eastern Partnership (EaP) Platform on Economic Integration and Convergence with EU Policies held on 9 November 2009. At this meeting it was agreed to establish a Panel on Trade and Trade Related Regulatory Cooperation – linked to the DCFTAs. The Panel's first meeting, to be held on 29-31 March 2010, will focus on the general issues such as the working methods, and the strategic customs issues. **DELETED** 

#### 2.4 EU-Russia Trade Relations: update

# 3.1 EU-Mongolia: debrief on 1<sup>st</sup> round of negotiations of the trade-related chapter of the PCA (Videoconference, 12<sup>th</sup> February 2010)

The Commission reported on the initial step in the negotiations for the Trade Chapter of the EU-Mongolia Partnership and Cooperation Agreement (PCA). EU relations with Mongolia are currently governed by the 1993 EU-Mongolia Agreement on trade and economic cooperation. A PCA negotiating mandate was approved by the Council in 2009. On this basis the first negotiating round, which had served primarily for presentation and clarification of the respective positions, took place on 12 February 2010 via videoconference. The next negotiating round is to be held on 18-19 March 2010 in Brussels. **DELETED**
