## Working Plan for the Counter-Terrorism Project Group

#### Introduction

The Counter-Terrorism Project Group (CTPG) was created in May 2004 as an informal subgroup to the Customs Cooperation Working Party (CCWP) to action the customs-related proposals being made in the EU and WCO to combat terrorism.

#### Aim

Its aim is to identify and promote ways enabling customs administrations to make a positive contribution to the fight against terrorism in response to and support of the Stockholm Programme, the Internal Security Strategy for the EU (5842/2/10 REV 2 JAI 90) and the EU Action Plan on Combating Terrorism.

### **Objective**

The key objectives of the group are to fulfil the objectives of the strategy for customs cooperation and the Action Plan implementing this strategy by:

- 1. Increasing the level of terrorism-awareness within customs administrations;
- 2. Identifying ways customs administrations can enhance their capabilities to combat terrorism (EU Action Plan on Combating Terrorism and the Stockholm Programme);
- 3. Carrying out operations to test customs ability to respond to the terrorist threat (the Stockholm Programme);
- 4. Enhancing inter-agency working (the Stockholm Programme);
- 5. Raising the political awareness of the role of customs and the contribution they can make to the fight against terrorism.

The UK has canvassed interest from the CCWP members to create an EU Technology Group to achieve a common approach towards detection technologies through interaction between public and private sectors to focus investment on standardisation, research, certification and interoperability of detection systems, to transform research results into useful and applicable tools, share information on technology development, consider the need for new / improved technology at the border, establish the specification requirements, work with suppliers to develop it and test equipment before procurement. The Commission's DG JLS meet with DG TAXUD and DG TREN to discuss the possibility of such a group. The first meeting of this group will take place on 25 and 26 January 2011 in Brussels. UK Customs will be meeting with these to discuss the way forward in September 2011.
