---

1. On 26 September 2013, the Commission submitted to the Council draft amending budget (DAB) No 8/2013. It concerns an increase in payment appropriations for a total amount of EUR 3.94 billion across (sub-)headings 1a, 1b, 2, 3a, 3b and 4 of the multiannual financial framework. This DAB concerns the remaining balance of DAB No 2/2013 adopted by the Council on 9 July 2013.
2. On 14 October 2013, as part of the compromise proposal presented by the Presidency, including DABs No 6/2013, No 8/2013 and No 9/2013, and transfer of appropriations No DEC 26/2013, the Permanent Representatives Committee reached an agreement, by a qualified majority<sup>1</sup>, on DAB No 8/2013 on the basis of document 14531/13.

- instruct the Presidency to prepare the budgetary documents to be sent to the European Parliament and approve the draft letter in Annex 2 to that effect;
- have the Council's position, as set out in Annex 1, published in the *Official Journal of the European Union*;
- enter into the Council's minutes the Commission statement recorded in Annex 3.

**COUNCIL DECISION**

**adopting the Council's position on draft amending budget No 8 of the European Union for the financial year 2013**

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Article 314 thereof, in conjunction with the Treaty establishing the European Atomic Energy Community, and in particular Article 106a thereof,

Having regard to Regulation (EC, Euratom) No 966/2012 of the European Parliament and of the Council of 25 October 2012 on the financial rules applicable to the general budget of the Union and repealing Council Regulation (EC, Euratom) No 1605/2002<sup>1</sup> and in particular Article 41 thereof,

Whereas:

- the Union's budget for the financial year 2013 was definitively adopted on 12 December 2012<sup>2</sup>,
- on 26 September 2013, the Commission submitted a proposal containing draft amending budget No 8 to the general budget for the financial year 2013,
- the Council's position is taken in conjunction with the adoption of its position on draft amending budget No 9/2013 and is subject to the European Parliament's approval of the agreement on the multiannual financial framework for 2014-2020,

- given the fact that draft amending budget No 8 to the general budget for 2013 needs to be adopted without delay, it is justified to shorten, in accordance with Article 3(3) of the Council's Rules of Procedure, the eight-week period for the information of national Parliaments, as well as the ten-day period foreseen for placing the item on the Council's provisional agenda laid down in Article 4 of Protocol No 1 on the role of national Parliaments in the European Union.

HAS DECIDED AS FOLLOWS:

*Sole Article*

The Council's position on draft amending budget No 8 of the European Union for the financial year 2013 was adopted on 30 October 2013.

This Decision shall apply from the date of the European Parliament's approval of the agreement on the multiannual financial framework for 2014-2020 and of the Council's position on draft amending budget No 9/2013.

**COMMISSION STATEMENT TO BE RECORDED IN THE COUNCIL MINUTES**

**Amending budget No 8/2013**

"The Commission will issue the call for funds for January 2014 shortly after 15 December 2013. In accordance with Regulation No 1150/2000, the due date for the payment of this call is the first working day of January 2014. The respect of the dates foreseen in that Regulation is justified notably in order to ensure an appropriate Commission's treasury planning and the effective management of its accounts.

However, taking into consideration the very exceptional situation prevailing at the end of 2013 and the delay in the adoption of draft amending budget No 8/2013, Member States may make total or partial payments after the call for funds but in advance of the above mentioned regulatory due date.

The Commission confirms that Member States' contributions corresponding to the GNI-based own resources required to finance amending budget No 8/2013 will be booked by Eurostat to the 2013 national budgets and accounts, even if the actual disbursement was to take place in January 2014, in accordance with the relevant accounting rules as applied by Eurostat."
